- If an error is made in the payment of your Direct Debit by FastPay Ltd Re Gardeners' Royal Benevolent Society t/a Perennial or your Bank or Building Society, you are entitled to a full and immediate refund of the amount paid from your

bank or building society.

- If you receive a refund you are not entitled to, you must pay it back when FastPay Ltd Re Gardeners' Royal Benevolent Society t/a Perennial asks you to.
- You can cancel a Direct Debit at any time by simply contacting your Bank or Building Society. Written confirmation may be required. Please also notify us.
